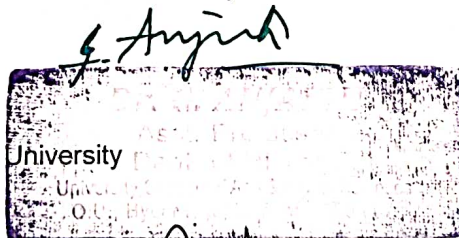

2.3 Details of choice based credit system.



2.7 Marks allotted for Internal and end Semester exams.
