MEMORANDUM OF UNDERSTANDING

THE FEDERATION OF TELANGANA AND ANDHRAPRADESH CHAMBERS OF COMMERCE AND INDUSTRY (FTAPCCI)

and HINDI MAHAVIDYALAYA (HMV)

- 5. This MoU begins on the effective date and expires on mutually agreed date with a notice period of six months, unless terminated earlier, in accordance with the MoU.
- This MoU in no way restrict the FTAPCCI & HMV from participating in similar activities with other private or public agencies, organizations or individuals.

- 7. Each party, upon 30 days of written notice, may terminate the MoU in whole or in part at any time before the expiration of the MoU without liability to the other party. Further either party may terminate the MoU, if the other party is in the breach of this MoU and fails to cure such breach within 10 days after written notice of the breach.
- 8. HMV recognizes the shared responsibility it has with the FTAPCCI to abide by various regulations. FTAPCCI Logo, Name or any other trade mark will not be used by HMV in their promotional material or elsewhere without a written consent.
- 9. Neither the FTAPCCI nor HMV will discriminate against any individual on the basis of age, creed, race, color, handicap, sex or national origin in connection with the program.

This Agreement constitutes the entire Agreement between the HMV and FTAPCCI and superseded all proposals or prior agreement, oral or written, and all other communications, oral or written. This agreement shall not be amended, altered or changed except by written agreement of both parties.

The Agreement is signed on 13th May, 2015 at Hyderabad.
