### MEMORANDUM OF UNDERSTANDING

Between

#### SANGEETHA'S YOGA

AND

**HMV** Hyderabad

The general objective of this Memorandum of Understanding (MOU) is for the development of academic cooperation in YOGA EDUCATION and to stimulate, facilitate the Development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and cultural development in both organizations. Thus, the company and HMV have agreed the following in support of their mutual interests.

The parties mutually agree to the following terms and conditions:

- 6. Each party, upon 30 days of written notice, may terminate the MOU in whole or in part at any time before the expiration of the MOU without liability to the other party. Further either party may terminate the MOU, if the other party is in the breach of this MOU and fails to cure such breach within 10 days after written notice of the breach.
